WE HAD ALMOST 400 BUDDIES, OVER 60 COACHES, AND APPROXIMATELY 150 OTHER VOLUNTEERS THROUGHOUT THESE SEASONS. OTHER VOLUNTEERS INCLUDED SNACK BAR OPERATIONS, FIELD OPENING AND CLOSING, BUDDY, COACH, PLAYER AND VOLUNTEER COORDINATORS, AND MISCELLANEOUS FUNDRAISING ASSISTANCE. IN TOTAL, DURING THE TWO SEASONS AND AT OUR FUNDRAISING EVENT, VOLUNTEERS CONTRIBUTED ALMOST 8,000 HOURS.
